## **Roll Cart Agreement**

### **What Can I put in my cart**

Most household trash can go in your cart as long as it's bagged and fits in the cart. Please keep the following in mind.

- Grass clippings and leaves must be bagged or they will not come out of the cart (or they come out at the wrong time or place).

### **Do Not Place Items**

- Hazardous Materials or Liquid Waste such as Poison, Acids, Caustics, Explosives, Oils, Gasoline, Paint, Paint thinner, Kerosene, Toxic Substances.
- Construction Materials(i.e. Concrete, wood, bricks, ect.) Furniture, Large pieces of steel are not allowed in the cart.
- Wood stove or fireplace ash cannot go in the cart unless they are bagged in a plastic bag (If it's too hot for a plastic bag it can and has started fires) Cool ash in a metal container until completely cool.
- Computers, computer components, TVs,
- Water dispensers, electric space heaters, electric radiant heaters(oil filled), Inferred round fan heaters, portable ceramic heaters, vacuums, shop vacs cannot go in the cart and will be charged an extra fee for disposal.
- **These items are not allowed in your regular garbage and you can be fined if you place them in your cart.**

### **Cart Placement**

- Carts are to be placed curbside by 6:00am (or the night before) on your trash pickup day.
- Carts need to be placed 5 feet away from other objects to allow clearance for the mechanical arm of the truck.
- Carts need to be placed clear of overhead power and other lines.
- If you are not sure where to place your cart contact the office and we will have a driver come by to find a location that works for you and us.

### **Cart Responsibility**

All carts are the property of Lakeview Sanitation, but keeping it clean and protecting it from being stolen are the users responsibility. Take care of it, don't abuse it, and it will last a long time. Stolen, damaged or abused carts are replaced at the property owner's or the responsible agent's expense. Do not mark, write, paint, cut or alter the cart in anyway. Each cart has a serial number which is recorded, so do not trade carts with your neighbors. If you end service the cart needs to be cleaned before being returned to Lakeview Sanitation.

Customer will indemnify and hold Lakeview Sanitation Services LLC harmless from all liability of any kind, for damages done by trucks, drivers, containers including curbs, pavements, driveways, sidewalks, etc., resulting from our trucks servicing in agreed upon areas. Customer further agrees to be responsible for any damages or injuries, while container is under Customer's care, custody, and control. In the event of a breach of the Agreement the Customer also agrees to pay any expense incurred by Lakeview Sanitation Services LLC to enforce this Agreement such as, collection fees, court fees and attorney fees.
