**Payment**

Payment for services is expected in full by the due date on your statement. If payment is not made your service can be discontinued. Please look closely at your statement, all statements will be considered correct and agreed to if you do not call

our office with questions within 30 days of statement. For one time or temporary containers all charges are due prior to service.

### **Weight Limit & over full containers**

**Please Do Not put apples, rocks, dirt, etc in the cart.** Containers need to have the lid closed to prevent trash spilling all over the street and animals from getting into the containers. If you have trash outside/on top of your container you will incur an extra charge.

### **What Can I put in my container**

Most household trash can go in your cart as long as it's bagged and fits in the container. Please keep the following in mind.

- Grass clippings and leaves must be bagged or they will not come out of the cart (or they come out at the wrong time or place).
- All containers are the property of Lakeview Sanitation, but keeping it clean and protecting it from being stolen are the user's responsibility. Take care of it, don't abuse it, and it will last a long time. Stolen, damaged or abused containers are replaced at the property owner's or the responsible agent's expense. Do not mark, write, paint, cut or alter the container in anyway.

• **Do Not Place Items** Such As Poison, Acids, Caustics, Explosives, Construction Materials(i.e. Concrete, wood bricks, roofing, ect.) Furniture, Oils, Gasoline, Paint, Paint thinner, Kerosene, Toxic Substances, Large pieces of steel in the cart. Wood stove or fireplace ash cannot go in the cart unless they are bagged in a plastic bag (If it's too hot for a plastic bag it can and has started fires) Cool ash in a metal container until completely cool. Tires cannot go in the cart. These items are considered hazardous and you can be fined if they are in your container.

### **Container Placement**

Containers must be placed on a hard, level surface with clear access for the truck. Once container has been placed do not move.

Containers must be placed away from overhead power lines.

Do not attempt to move containers with forklifts, tractor, backhoes, etc. If you need the container moved please call the office.

**One Time or Temporary Containers**

We do have containers available for one time or temporary jobs. Payment is due in advance for these.

Customer will indemnify and hold Lakeview Sanitation Services LLC harmless from all liability of any kind, for damages done by trucks, drivers, containers including curbs, pavements, driveways, sidewalks, etc., resulting from our trucks servicing in agreed upon areas. Customer further agrees to be responsible for any damages or injuries, while container is under Customer's care, custody, and control. In the event of a breach of the Agreement the Customer also agrees to pay any expense incurred by Lakeview Sanitation Services LLC to enforce this Agreement such as, collection fees, court fees and attorney fees.
